GAMBARAN MONITORING DAN EVALUASI KEGIATAN KOMITE REKAM MEDIS DI RSUD ULIN BANJARMASIN

Komite rekam medis adalah suatu kelompok kerja atau tim/panitia yang menyusun, mengawasi, dan meningkatkan kualitas rekam medis. Komite rekam medis memiliki fungsi untuk mengawasi dan memonitoring kegiatan pemantauan unit rekam medis rumah sakit agar sesuai dengan standar pelayanan atau prosedur tetap yang telah ditetapkan oleh rumah sakit guna menjamin kualitas mutu rekam medis. Penelitian ini bertujuan untuk mengetahui gambaran monitoring dan evaluasi kegiatan komite rekam medis di RSUD Ulin Banjarmasin. Penelitian ini menggunakan metode penelitian deskriptif dengan menggunakan teknik pengumpulan data wawancara dan observasi kepada ketua komite rekam medis dan anggota komite rekam medis. Hasil dari penelitian ini menunjukkan bahwa perencanaan kegiatan komite rekam medis di RSUD Ulin Banjarmasin yakni membantu dalam mengoptimalkan pengelolaan rekam medis yang baik telah dilaksanakan. Pelaksanaan kegiatannya pun sudah memiliki SOP yang digunakan sebagai acuan melaksanakan kegiatan komite rekam medis serta pelaksanaan rapat yang telah dilaksanakan secara rutin namun tidak semua anggota komite rekam medis dapat mengikuti kegiatan tersebut. Monitoring dalam pelaksanaannya telah dilaksanakan sesuai dengan tugas pokok yang telah diberikan dan secara khusus tidak ada yang memonitoring kecuali mendesak. Saat evaluasi pelaksanaan kegiatan komite rekam medis masih ditemui beberapa kendala akan tetapi kegiatan ini sangat membantu dalam meningkatkan kualitas mutu rekam medis terutama menjaga rekam medis sehingga diharapkan kegiatan ini dapat membawa rekam medis RSUD Ulin Banjarmasin menjadi rekam medis elektronik.

OVERVIEW OF MONITORING AND EVALUATION OF THE MEDICAL RECORD COMMITTEE ACTIVITIES AT ULIN HOSPITAL BANJARMASIN

Medical record committee is a working group or team / committee that arranges, supervises, and improves the quality of medical records. The medical record committee has the function to supervise and monitor the monitoring activities of the hospital's medical record unit to comply with the service standards or fixed procedures set by the hospital to ensure the quality of the medical record. This study aims to determine the description of monitoring and evaluation of the medical record committee activities at Ulin Hospital Banjarmasin. This research uses descriptive research method by using interview and observation data collection techniques to the chairman of the medical record committee and members of the medical record committee. The results of this study indicate that the planning of medical record committee activities at Ulin Banjarmasin Hospital, namely helping in optimizing the management of good medical records has been carried out. The implementation of its activities also has an SOP which is used as a reference for carrying out medical record committee activities as well as conducting meetings that have been carried out routinely but not all members of the medical record committee can participate in these activities. Monitoring in its implementation has been carried out in accordance with the main tasks that have been given and specifically there is no monitoring unless urgent. When evaluating the implementation of the medical records committee activities, there were still some obstacles encountered, but this activity was very helpful in improving the quality of the medical records, especially maintaining the medical records so that this activity was expected to bring the medical records of Ulin Banjarmasin Hospital into an electronic medical record.
