GAMBARAN TINGKAT PENGETAHUAN PERAWAT TENTANG PENGEMBALIAN BERKAS REKAM MEDIS DI RS TK.III Dr. R. SOEHARSONO BANJARMASIN

Rekam medis rawat inap harus dikembalikan ke unit rekam medis 2x24 jam setelah pasien pulang. Keterlambatan pengembalian mengakibatkan penumpukan dokumen rekam medis rawat inap juga pada akhirnya menjadi beban petugas assembling. Penelitian ini bertujuan untuk mengetahui gambaran tingkat pengetahuan perawat tentang pengembalian berkas rekam medis di RS TK.III Dr. R. Soeharsono Banjarmasin. Jenis penelitian ini deskriptif. Populasi penelitian ini adalah seluruh perawat rawat inap ruang Gardania, ruang Flamboyan, ruang Wira, dan ruang Sakti di RS TK.III Dr. R. Soeharsono Banjarmasin yang berjumlah 38 orang diambil dengan total sampling. Data primer dalam penelitian ini langsung dari responden dengan kuesioner. Analisis menggunakan analisis univariat. Hasil penelitian menunjukkan bahwa semua perawat di RS TK.III dr. R. Soeharsono Banjarmasin memiliki rentang umur 22-48 tahun atau masuk dalam kategori produktif. Berpendidikan D-III Keperawatan (92,1%). Lama kerja perawat masuk dalam kategori lama (>3 tahun) dengan persentase 84,2%. Tingkat pengetahuan perawat lebih banyak berpengetahuan cukup berjumlah 24 responden dari 38 responden dengan persentase 63,2%. Sebaiknya rekam medis harus dikembalikan tepat waktu yaitu 2 X 24 jam setelah pasien pulang atau selesai perawatan agar pelayanan kesehatan tidak terhambat seperti assembling, pengkodingan, dan pelaporan.

An inpatient medical record must be returned to a medical record unit 2x24 hours after the patient comes home. Late returns resulting in the buildup of the hospitalisation of medical records also eventually become the burden of assembling officers. This research aims to figure out the knowledge level of the nurse about the return of medical record file at TK. III Dr. R. Soeharsono Hospital Banjarmasin. This type of research is descriptive. The population of this research is the entire hospitalisation nurse of Gardania, the flamboyant room, the Wira room, and the Sakti room in TK. III Dr. R. Soeharsono Hospital Banjarmasin which amounted to 38 people taken with a total sampling. The primary Data in this research is directly from respondents with questionnaires. Analysis using univariate analysis. The results showed that all nurses in TK. III Dr. R. Soeharsono Hospital Banjarmasin has an age range of 22-48 years or is in the productive category. Educated D-III nursing (92.1%). The length of the nurse's work is in the old category (> 3 years) with a percentage of 84.2%. The knowledge level of nurses is more knowledgeable enough to number 24 respondents from 38 respondents with a percentage of 63.2%. It is recommended that the medical record should be returned on time i.e. 2 X 24 hours after the patient comes home or finished treatment so that the health care is not hindered such as assembling, recording, and reporting.
