Rekam Medis harus diberi map pelindung untuk memelihara keutuhan susunan lembaran-lembaran rekam medis, mencegah terlepas atau tersobeknya lembaran sebagai akibat dari sering dibolak-baliknya lembaran tersebut. Tujuan penelitian ini adalah mendesain ulang map rekam medis di Puskesmas Guntung Manggis Tahun 2020. Jenis penelitian ini adalah penelitian deskriptif, pengumpulan data dilakukan dengan cara observasi dan wawancara. Subjek penelitian adalah map rekam medis dan petugas rekam medis. Hasil penelitian ini adalah map rekam medis Puskesmas Guntung Manggis belum sesuai dengan standar aspek anatomi, fisik, dan isi. Pada map rekam medis terdahulu hanya terdapat komponen nama pasien, nomor rekam medis dan ruler saja. Dapat disimpulkan bahwa map rekam medis di Puskesmas Guntung Manggis perlu ditambahkan aspek anatomi meliputi *header* dan *footer*, *introduction*, *fonts*, dan *ruler*. Aspek fisik meliputi bahan, warna, ukuran, dan ketebalan. Aspek isi meliputi identitas sarana pelayanan kesehatan, tulisan rahasia, nama pasien, nomor rekam medis, dan tahun kunjungan terakhir. Sebaiknya hasil rancangan map rekam medis dari penelitian ini dapat diterapkan di Puskesmas Guntung Manggis.

### **REDESIGN OF MEDICAL RECORD FOLDER AT GUNTUNG MANGGIS PUBLIC HEALTH CENTER, 2020.**

*Medical records must be provided with protective folder to protect the integrity of the composition of the medical sheet, prevent the release or tearing of the sheets which are flipped. The purpose of this study is to redesign the medical record folder at Guntung Manggis Public Health Center, 2020. This type of research is descriptive research, data collection is done by observation and interview. Research subjects were medical record folder and medical records officers. The results of this study are the medical record folder of Guntung Manggis Public Health Center not in accordance with the standards of anatomical, physical, and content aspects. In the previous medical record folder there are only components of the patient's name, medical record number and ruler only. It can be concluded that the medical record folder in Guntung Manggis Public Health Center needs to be added anatomical aspects including header and footer, introduction, fonts, and ruler. Physical aspects include material, color, size, and thickness. Content aspects include the identity of health service facilities, confidential writing, patient's name, medical record number, and the year of the last visit. The results of the draft medical record folder from this study should be applied at the Guntung Manggis Public Health Center.*
