ANALISIS KELENGKAPAN PENGISIAN FORMULIR RESUME MEDIS PENDERITA DIABETES MELLITUS DI INSTALASI RAWAT INAP RSUD RATU ZALECHA MARTAPURA TAHUN 2021

Berdasarkan Kepmenkes 129/Menkes/SK/II/2008 tentang Standar Pelayanan Minimal (SPM) rumah sakit bahwa standar kelengkapan pengisian rekam medis setelah pelayanan diketahui bahwa yaitu harus 100% dimana berkas resume medis terdiri dari informasi administratif, klinis dan otentifikasi. Pada RSUD Ratu Zalecha Martapura diketahui bahwa, dalam pengisian formulir resume medis pada pasien diabetes mellitus di instalasi rawat inap sebanyak 67% dari 18 sampel dokumen rekam medis ditemukan ketidak lengkapan pengisian formulir pada item tanggal masuk, terapi pengobatan, dan kondisi waktu pulang. Tujuan penelitian ini adalah untuk mengetahui kelengkapan pengisian formulir resume medis penderita diabetes mellitus di Instalasi Rawat Inap Rumah Sakit Umum Daerah Ratu Zalecha Martapura Tahun 2021. Penelitian ini menggunakan rancangan deskriptif kuantitatif. Sampel dalam penelitian ini berjumlah 210 formulir resume medis penderita diabetes mellitus di Instalasi Rawat Inap RSUD Ratu Zalecha Martapura bulan Januari-Maret di ambil dari total populasi. Hasil penelitian ini menunjukkan bahwa kelengkapan pengisian resume medis dari segi data administrasi, data klinis, dan data otentifikasi di RSUD Ratu Zalecha Martapura tahun 2021 termasuk kategori tidak lengkap, yang artinya masih belum sesuai dengan Standar Pelayanan Minimum (SPM) tentang kelengkapan pengisian resume medis dengan target kelengkapan 100%.

ANALYSIS OF COMPLETENESS OF FILLING MEDICAL RESUME FORM FOR DIABETES MELLITUS PATIENTS IN INSTALLATION INPATIENT AT RATU ZALECHA MARTAPURAREGIONAL GENERAL HOSPITAL IN 2021

Based on Kepmenkes 129/Menkes/SK/II/2008 concerning Minimum Service Standards (SPM) for hospitals, it is known that the standard for completing medical record filling after service is known to be 100% where the medical resume file consists of administrative, clinical and authentication information. At RSUD Ratu Zalecha Martapura, it is known that, in filling out medical resume forms for diabetes mellitus patients in inpatient installations, 67% of the 18 samples of medical record documents found incomplete forms of filling in items on date of admission, treatment therapy, and conditions of time to go home. The purpose of this study was to determine the completeness of filling out a medical resume form for people with diabetes mellitus at the Inpatient Installation of the Ratu Zalecha Martapura Regional General Hospital in 2021. This study used a quantitative descriptive design. The sample in this study amounted to 210 medical resume forms for people with diabetes mellitus at the Inpatient Installation of Ratu Zalecha Hospital Martapura in January-March taken from the total population. The results of this study indicate that the completeness of filling out a medical resume in terms of administrative data, clinical data, and authentication data at Ratu Zalecha Hospital Martapura in 2021 is included in the incomplete category, which means that it is still not in accordance with the Minimum Service Standards (SPM) regarding the completeness of filling out a medical resume with 100% completeness target..
