## **ANALISIS REKAM MEDIS PASIEN GAWAT DARURAT SESUAI STANDAR AKREDITASI DIRUMAH SAKIT ISLAM BANJARMASIN TAHUN 2021**

Rekam medis gawat darurat adalah rekam medis yang berisi catatan tindakan medis pada pasien gawat darurat untuk meningkatkan mutu rumah sakit rekam medis gawat darurat harus memenuhi standar akreditasi. Tujuan penelitian menganalisis keadaan rekam medis pasien gawat darurat sesuai standar akreditasi di Rumah Sakit Islam Banjarmasin. Metode penelitian yaitu penelitian kuantitatif didukung oleh kualitatif. Subjek dengan informan utama yaitu kepala instalasi rekam medis pada bagian instalasi rekam medis, dan informan tringulasi yaitu dengan kepala instalasi rawat inap pada bagian instalasi rawat inap dan kepala instalasi gawat darurat pada bagian instalasi gawat darurat. Populasi adalah seluruh berkas rekam medis gawat darurat pada bulan Januari-Maret 2021 sebanyak 800 berkas. Sedangkan sampel menggunakan teknik *simple random sampling* terdapat 267 berkas. Instrumen penelitian ini observasi dan wawancara. Teknik analisa data kuantitatif menggunakan analisis univariat, sedangkan data kualitatif menggunakan pengumpulan data, reduksi data, *display* data (penyajian data) dan *conclusion drawing / verification*. Hasil penelitian menunjukkan bahwa regulasi di Rumah Sakit Islam Banjarmasin di instalasi gawat darurat sudah sesuai dengan kategori terpenuhi. Rekam medis waktu kedatangan sudah terisi lengkap, dan pada waktu keluar pasien tidak terisi lengkap. Terdapat ringkasan kondisi pasien diagnosa primer terisi lengkap dan untuk diagnosa sekunder tidak terisi lengkap. Terdapat instruksi tindak lanjut asuhan pasien gawat darurat yang sudah sesuai dengan standar akreditasi rumah sakit.

### **MEDICAL RECORD ANALYSIS OF EMERGENCY PATIENTS ACCORDING TO ACCREDITATION STANDARDS IN BANJARMASIN ISLAMIC HOSPITAL IN 2021**

*Emergency medical record is a medical record that contains records of medical actions in an emergency situation to improve the quality of hospital emergency medical records must meet accreditation standards. The purpose of this research is to analyze emergency medical conditions according to accreditation standards at the Banjarmasin Islamic Hospital. The research method is quantitative research supported by qualitative. Subjects with the main informant were the head of the medical record installation at the medical record installation section, and the triangulation informant, namely the head of the inpatient installation at the inpatient installation section and the head of the emergency department at the emergency department. The population is all emergency medical record files in January-March 2021 as many as 800 files. While the sample using simple random sampling technique there are 267 files. The research instrument is observation and interviews. The data analysis technique used univariate analysis, data collection, data reduction, data display (data presentation) and conclusion drawing/verification. The results showed that the regulations at the Banjarmasin Islamic Hospital in the emergency department were in accordance with the fulfilled category. The medical record of the arrival time is completely filled out, and the patient's time of discharge is not completely filled out. There is a summary of the patient's condition, the primary diagnosis is complete and the secondary diagnosis is incomplete. There are follow-up instructions for emergency patient care that are in accordance with hospital accreditation standards.*
