TINJAUAN KELENGKAPAN ASSESMENT REKAM MEDIS PASIEN RAWAT JALAN DI RSUD dr. H. ANDI ABDURRAHMAN NOOR Tahun 2021.

Kelengkapan Rekam Medis harus dibuat secara tertulis, lengkap, dan jelas atau secara elektronik. Untuk mengetahui kelengkapan pada item-item berkas rekam medis dilakukan melalui analisis kuantitatif. Berdasarkan studi pendahuluan di RSUD dr. H. Andi Abdurrahman Noor dari 10 rekam medis diantaranya 4 (40%) rekam medis belum terisi diagnosa dan 6 (60%) berkas rekam medis rawat jalan belum ditandatangani oleh dokter yang memeriksa hal ini disebabkan dokter sering lupa untuk menandatangani assesmen rawat jalan karena jumlah pasien yang banyak dan kesibukan dokter lainnya. Tujuan penelitian ini untuk mengidentifikasi kelengkapan assesmen rekam medis rawat jalan di RSUD dr. H. Andi Abdurrahman Noor. Metode penelitian ini menggunakan metode deskriptif kualitatif. Subjek penelitian ini terdiri dari informan utama yaitu kepala rekam medis 1 orang dokter, triangulasi 1 orang petugas analisis. Populasi dalam penelitian ini adalah semua berkas rekam medis pasien rawat jalan di RSUD dr. H. Andi Abdurrahman Noor Kabupaten Tanah Bumbu sebanyak 684 berkas rekam medis. Teknik sampel yang digunakan yaitu sampel random sampling yang di dapat 87 sampel. Instrumen penelitian ini yaitu pedoman wawancara, ceklis dan observasi. Teknik analisa data ini yaitu kuantitatif yang didukung kualitatif. Hasil penelitan didapat bahwa kelengkapan pengisian assesmen rawat jalan yaitu 57% rekam medis dan ketidaklengkapan yaitu 43 % rekam medis meliputi : ketidaklengkapan pemeriksaan fisik 39%, terapi/pengobatan 21 %, diagnosa 8 %. Faktor ketidaklengkapan assesmen rekam medis adalah jam kerja dokter yang sibuk, beban kerja dengan jumlah yang banyak dan beberapa dokter terlambat datang dengan jam buka poliklinik. Saran sebaiknya dilakukan analisa terkait pengisian berkas rekam medis sebelum dikembalikan.

REVIEW OF MEDICAL RECORD ASSESSMENT COMPLETENESS OUT PATIENT IN RSUD dr. H. ANDI ABDURRAHMAN NOOR in 2021.

Completeness of Medical Records must be made in writing, complete, and clear or electronically. To find out the completeness of the items in the medical record file, quantitative analysis was carried out. Based on a preliminary study at RSUD dr. H. Andi Abdurrahman Noor of 10 medical records including 4 (40%) medical records that have not been filled with diagnoses and 6 (60%) of the outpatient medical record files have not been signed by the examining doctor, this is because doctors often forget to sign an outpatient assessment because the number the number of patients and the busyness of other doctors. The purpose of this study was to identify the completeness of the outpatient medical record assessment at dr. H. Andi Abdurrahman Noor. This research method uses a descriptive method with the subject of research informants, namely the head of the medical record 1 doctor, 2 analysis officers. The population in this study is the medical record file of outpatients in RSUD dr. H. Andi Abdurrahman Noor Tanah Bumbu Regency as many as 684 medical record files. The sampling technique used is random sampling which obtained 87 samples. The instrument of this research is interview guide, checklist and observation, the data analysis technique of this research is quantitative which is supported by qualitative. The results of the study showed that the completeness of filling out the outpatient assessment was 57% of medical records and the incompleteness of 43% of medical records included: 39% incomplete physical examination, 21% therapy/treatment, 8% diagnosis. Factors for incomplete medical record assessment are busy working hours, large workloads and some doctors are late with the opening hours of the polyclinic. Suggestions should be analyzed related to filling out the medical record file before returning it.
