### TINJAUAN KELENGKAPAN PENGISIAN FOMULIR *INFORMED CONSENT* RSU.SUAKA INSAN BANJARMASIN TAHUN 2021

Kelengkapan pengisian lembar *informed consent* pada berkas rekam medis sangat penting karena akan mempengaruhi aspek hukum rekam medis dan mutu rekam medis sehingga dalam pengisian kelengkapan data dalam lembar *informed consent* perlu dilakukan dengan pelaksanaan yang maksimal. Tujuan penelitian ini adalah untuk mengetahui kelengkapan pengisian formulir informed consent di Rumah Sakit Umum Suaka Insan. Metode penelitian menggunakan metode penelitian deskriptif, sampel yang digunakan adalah rekam medis rawat inap berjumlah 87 berkas. Hasil penelitian yaitu kelengkapan pengisian formulir *informed consent* dari segi identitas pasien di Rumah Sakit Umum Suaka Insan adalah 100 %, kelengkapan pengisian formulir *informed consent* dari segi pemberian informasi di Rumah Sakit Umum Suaka Insan adalah 66,1 %, kelengkapan pengisian formulir *informed consent* dari segi jenis informasi di Rumah Sakit Umum Suaka Insan adalah 54,8%, kelengkapan pengisian formulir *informed consent* dari segi autentifikasi di Rumah Sakit Umum Suaka Insan adalah 76,7%. Penyebab ketidaklengkapan pengisian formulir *informed consent* dari segi Sumber Daya Manusia di RSU. Suaka Insan Banjarmasin adanya dokter yang sering tidak mengisi formulir *informed consent*, tidak ada dokter jaga atau perawat ruangan yang bertugas melengkapi formulir *informed consent*, DPJP sering tidak berada di rumah sakit, tidak ada koordinasi antara perawat dan dokter untuk pengisian *informed consent*, dan kedisiplinan dokter kurang dalam pengisian formulir *informed consent*. Kesimpulan pada penelitian ini menyatakan bahwa kelengkapan pengisian formulir *informed consent* di Rumah Sakit Umum Suaka Insan adalah 74,4%.

*The completeness of filling out the informed consent sheet in the medical record file is very important because it will affect the legal aspects of the medical record and the quality of the medical record so that filling in the completeness of the data in the informed consent sheet needs to be carried out with maximum implementation. The purpose of this study was to determine the completeness of filling out the informed consent form at the Insan Asylum General Hospital. The research method uses descriptive research methods, The sample used is inpatient medical records totaling 87 files. The results of the study are that the completeness of filling out the informed consent form in terms of patient identity at the Insan Asylum General Hospital is 100%, the completeness of filling out the informed consent form in terms of providing information at the Insan Asylum General Hospital is 66.1%, the completeness of filling out the informed consent form in terms of the type of information at the Insan Asylum General Hospital is 54.8%, the completeness of filling out the informed consent form in terms of authentication at the Insan Asylum General Hospital is 76.7%. The cause of the incomplete filling of the informed consent form in terms of Human Resources at the Suaka Insan Hospital, there are doctors who often do not fill out the informed consent form, there is no doctor on duty or room nurse in charge of completing the informed consent form, the doctors often not in the hospital, there is no coordination between nurses and doctors for filling out informed consent, and the discipline of doctors lacking in filling out the informed consent for. The conclusion of this study stated that the completeness of filling out the informed consent form at the Insan Asylum General Hospital was 74.4%.*
