Evaluasi Penanganan Dokumen Rekam Medis Terkait Penyebaran Infeksi Covid-19 di Rumah sakit Tk.III Dr. R. Soeharsono Banjarmasin Tahun 2021

Pada tanggal 25 maret 2020, Ketua Umum Dewan Pimpinan Pusat PORMIKI mengeluarkan Surat Edaran Nomor HM.01.01/002/III/2020 tentang Prosedur Perkam Medis dan Informasi Kesehatan dalam situasi wabah covid-19. Berdasarkan hasil studi pendahuluan di Rumah sakit Tk.III Dr. R. Soeharsono Banjarmasin, penanganan rekam medis pasien covid-19 belum dilakukan sesuai arahan dari PORMIKI. Rekam medis tidak dimasukkan ke dalam plastik, tidak dimasukkan kedalam boks kontainer, dan tidak disimpan di tempat khusus. Penelitian ini bertujuan untuk mengevaluasi penanganan dokumen rekam medis terkait penyebaran infeksi covid-19 di Rumah sakit Tk.III Dr. R. Soeharsono Banjarmasin. Penelitian ini menggunakan pendekatan kualitatif metode deskriptif, menggunakan 4 informan utama (2 orang perawat pasien covid-19 dan 2 orang petugas rekam medis) dan 2 informan triangulasi (kepala perawat pasien covid-19 dan kepala instalasi rekam medis). Instrumen penelitian yang digunakan adalah pedoman observasi dan wawancara. Hasil penelitian menunjukkan bahwa Prosedur pemeliharaan rekam medis selama masa perawatan di rawat inap sudah sesuai dengan arahan dari PORMIKI, sedangkan Prosedur pemeliharaan rekam medis pasien pulang belum sesuai dengan arahan dari PORMIKI. Penanganan dokumen rekam medis pasien covid-19 yang belum sesuai dengan arahan PORMIKI dan SOP dapat memungkinkan terjadinya penyebaran infeksi covid-19.

On March 25, 2020, the General Chairperson of the PORMIKI Central Executive Board issued Circular Letter Number HM.01.01/002/III/2020 concerning Procedures for Medical Recorders and Health Information in the Covid-19 outbreak situation. Based on the results of a preliminary study at the Tk.III Hospital Dr. R. Soeharsono Banjarmasin, the handled of the medical record files of Covid-19 patients has not been carried out according to the direction of PORMIKI. Medical record files are not put in plastic, not put in a container box, and not stored in a special place. This study aims to evaluate the handled of medical record documents related to the spread of COVID-19 infection at the Tk.III Dr. Hospital. R. Soeharsono Banjarmasin. This study uses a qualitative descriptive approach, using 4 main informants (2 nurses for COVID-19 patients and 2 medical record officers) and 2 triangulation informants (head nurses for COVID-19 patients and head of the medical record installation). The research instrument used was an observation and interview guide. The results showed that the procedure for maintaining medical record files during the inpatient treatment period was in accordance with the directions from PORMIKI, while the procedures for maintaining medical record files for returning patients were not in accordance with the directions from PORMIKI. Handled of medical record documents for COVID-19 patients that are not in accordance with PORMIKI directions and SOPs can allow the spread of COVID-19 infection.
