### **TINJUAN PELAKSANAAN PENGISIAN *GENERAL CONSENT* RAWAT INAP BERDASARKAN KEPATUHAN PETUGAS REKAM MEDIS DI RUMAH SAKIT ISLAM BANJARMASIN TAHUN 2022.**

*General consent* adalah formulir persetujuan umum yang selalu diajukan kepada pasien atau keluarga sebelum menerima pelayanan rawat jalan dan rawat inap di rumah sakit. Berdasarkan hasil studi pendahuluan yang dilakukan di Rumah Sakit Islam Banjarmasin pada tanggal 18 November 2021 di dapat bahwa pada saat melakukan observasi petugas pendaftaran tidak menyampaikan fungsi dan manfaat *general consent* kepada pihak keluarga serta yang terjadi dilapangan, keluarga pasien hanya di minta untuk tanda tangan tanpa diminta untuk membacanya terlebih dahulu, penjelasan *general consent* masih kurang informatif karena masih ada pasien atau keluarga tidak mendapat penjelasan dan kurang memahami isi *general consent*. Tujuan penelitian adalah mengetahui pelaksanaan pengisian formulir *general consent* berdasarkan kepatuhan petugass rekam medis di Rumah Sakit Islam Banjarmasin. Metode penelitian adalah deskriptif dengan sampel 88 formulir general consent pada berkas rekam medis serta 2 orang petugas pendafrtan passion rawat inap dan 1 orang kepala instalasi rekam medis. Hasil penelitian diketahui bahwa tidak terdapat SPO pengisian formulir *general consent* di Rumah Sakit Islam Banjarmasin, Kelengkapan pengisian formulir *general consent* di Rumah Sakit Islam Banjarmasin tidak lengkap 100% karena hanya mencapai 87,1%, Petugas pendaftaran pasien rawat inap tidak patuh dalam pengisian formulir *general consent* karena tidak melaksanakan sesuai tahapan pengisian mulai dari persiapan, pelaksanaan, dan pendokumentasian. Saran untuk penelitian ini sebaiknya Rumah Sakit Islam Banjarmasin membuat SPO tentang pengisian formulir *general consent*.

### **OVERVIEW OF IMPLEMENTATION OF FILLING IN INPATIENT GENERAL CONSENT BASED ON MEDICAL RECORD OFFICERS' COMPLIANCE AT THE ISLAM BANJARMASIN HOSPITAL IN 2022**

*General consent is a general consent form that is always submitted to the patient or family before receiving outpatient and inpatient services at a hospital. Based on the results of a preliminary study conducted at the Banjarmasin Islamic Hospital on November 18, 2021, it was found that when observing the registration officer did not convey the functions and benefits of general consent to the family and what happened in the field, the patient's family was only asked to sign without being asked. to read it first, the explanation of general consent is still not informative because there are patients or families who do not receive an explanation and do not understand the contents of general consent. The purpose of the study was to determine the implementation of filling out the general consent form based on the compliance of medical record officers at the Banjarmasin Islamic Hospital. The research method is descriptive with a sample of 88 general consent forms in the medical record file and 2 inpatient passion registration officers and 1 head of the medical record installation. The results of the study found that there was no SOP for filling out the general consent form at the Banjarmasin Islamic Hospital, the completeness of filling out the general consent form at the Banjarmasin Islamic Hospital was incomplete 100% because it only reached 87.1%, the inpatient registration officer did not comply in filling out the general form. consent for not carrying out according to the filling stages starting from preparation, implementation, and documentation. Suggestions for this research is that the Banjarmasin Islamic Hospital should make an SPO regarding filling out the general consent form.*
