### **ANALISIS KELENGKAPAN FORMULIR *INFORMED CONSENT* PASIEN RAWAT INAP BERDASARKAN SPM DI RSUD DR. H. MOCH ANSARI SALEH BANJARMASIN**

*Informed Consent* adalah persetujuan yang diberikan oleh pasien atau keluarga terdekatnya setelah mendapatkan penjelasan secara lengkap mengenai tindakan kedokteran atau kedokteran gigi yang akan dilakukan terhadap pasien. *Informed consent* yang lengkap adalah kelengkapan nama, tanda tangan dokter dan keluarga pasien sehingga pasien, dokter dan rumah sakit dapat mencegah kasus-kasus hukum yang akan terjadi. Tetapi faktanya di lapangan formulir *informed consent* masih banyak yang belum terisi 100% yang dapat mengakibatkan terhambatnya pelayanan rumah sakit dan dapat menyebabkan hal lainnya yang tidak diinginkan terjadi. Tujuan penelitian ini mengetahui analisis kelengkapan pengisian formulir *informed consent* pasien rawat inap berdasarkan SPM di RSUD Dr. H. Moch Ansari Saleh Banjarmasin. Metode Penelitian menggunakan metode deskriptif kualitatif dengan subjek penelitian informan utama yaitu petugas analisis dan informan triangulasi yaitu kepala instalasi rekam medis. Instrumen penelitian ini yaitu pedoman observasi dan pedoman wawancara, teknik analisis data penelitian ini yaitu kuantitatif didukung kualitatif. Dari hasil penelitian kelengkapan pengisian dari segi identitas pasien mencapai (95,6%) lengkap. Kelengkapan pengisian dari segi pemberian informasi mencapai (59,6%) lengkap. Kelengkapan pengisian dari segi jenis informasi mencapai (36,7%) lengkap. Kelengkapan pengisian dari segi autentifikasi mencapai (81,4%) lengkap dan persentase pencatatan yang baik pengisian formulir *informed consent* mencapai (98,7%).

### **ANALYSIS OF COMPLETENESS OF INFORMED CONSENT FORM IN INPATIENT PATIENTS BASED ON SPM IN RSUD DR. H. MOCH ANSARI SALEH BANJARMASIN**

*Informed Consent is consent given by the patient or his closest family after receiving a complete explanation regarding the medical or dental procedures to be performed on the patient. Complete informed consent is the completeness of the name, signature of the doctor and the patient's family so that the patient, doctor and hospital can prevent legal cases that will occur. But the fact is that in the field there are still many informed consent forms that have not been filled in 100% which can result in delays in hospital services and can cause other unwanted things to happen. The purpose of this study was to find out the analysis of the completeness of filling in the informed consent form for inpatients based on the SPM at Dr. H. Moch Ansari Saleh Banjarmasin. The research method uses a qualitative descriptive method with the main informant being the research subject, namely the analysis officer and the triangulation informant, namely the head of the medical record installation. The research instruments were observation guidelines and interview guidelines. The data analysis technique in this research was quantitative and qualitative. From the results of the study the completeness component of filling out the informed consent form in terms of patient identity reached (95.6%) complete. Completeness of filling out the informed consent form in terms of providing information reached (59.6%) complete. Completeness of filling out the informed consent form in terms of the type of information reached (36.7%) complete. Completeness of filling out the informed consent form in terms of authentication reached (81.4%) complete and the percentage of good recording of filling out the informed consent form reached (98.7%).*
