### **Tinjauan Kesiapan Implementasi Rekam Medis Elektronik Di Rumah Sakit Umum Nirwana**

Rumah Sakit Umum Nirwana telah memiliki sistem informasi manajemen rumah sakit, namun beberapa pelayanan lainnya masih menggunakan rekam medis konvensional, dan ada yang masih belum dicatat dalam SIMRS dikarenakan tidak adanya perangkat komputer, hal ini menyebabkan belum berkesinambungan data klinis di Rumah Sakit Umum Nirwana. Penelitian ini ingin mengetahui bagaimana kesiapan penerapan Implementasi Rekam Medis Elektronik di Rumah Sakit Umum Nirwana berdasarkan unsur Sumber Daya Manusia (*Man*), Anggaran (*Money*), pelaksanaan (*Method*), alat yang digunakan (*Machine*) dan bahan yang digunakan (*Material*). Didapatkan hasil bahwa kesiapan sumber daya manusia untuk instalasi rekam medis di Rumah Sakit Umum Nirwana masih belum mencukupi, tersedianya alokasi dana untuk kesiapan dan pemeliharaan sistem rekam medis elektronik di Rumah Sakit Umum Nirwana. Belum tersedianya Standar Operasional Prosedur pengoprasi rekam medis elektronik di Rumah sakit Umum Nirwana, belum tersedianya komputer dan jaringan yang memadai pada beberapa bagian pelayanan, namun setiap komputer sudah terinstal windows serta aplikasi SIMRS Kanza untuk memudahkan petugas dalam bekerja.

### **REVIEW OF READINESS FOR IMPLEMENTATION OF ELECTRONIC MEDICAL RECORDS AT NIRWANA GENERAL HOSPITAL, 2023**

Nirwana General Hospital already has a hospital management information system, but several other services still use conventional medical records, and some are still not recorded in the SIMRS due to the absence of a computer device, this causes clinical data to be discontinued at Nirwana General Hospital . This study wants to find out how the readiness of implementing Electronic Medical Record Implementation at Nirwana General Hospital is based on the elements of Human Resources (Man), Budget (Money), implementation (Method), tools used (Machine) and materials used ( materials). The results show that the readiness of human resources for the installation of medical records at Nirwana General Hospital is still insufficient, the availability of allocation of funds for the readiness and maintenance of the electronic medical record system at Nirwana General Hospital, the unavailability of standard operating procedures for operating electronic medical records at public hospitals. Nirwana, There are not yet adequate computers and networks in some service departments, but Windows and the SIMRS Kanza application are installed on each computer to make it easier for officers to work.
