ANALISIS KEAKURATAN KODIFIKASI PENYAKIT PADA SISTEM PENCERNAAN BERDASARKAN CD-10 DI PUSKESMAS LANDASAN ULIN BANJARBARU

Keakuratan kode diagnosis penyakit sangat penting karena menghasilkan informasi yang benar dan dapat dipertanggung jawabkan. Hasil pengkodean harus mencerminkan keadaan pasien dan tindakan atau prosedur yang di terima oleh pasien. Tujuan penelitian ini adalah mengetahui keakuratan kodifikasi penyakit pada sistem pencernaan berdasarkan ICD-10. Jenis penelitian yang digunakan adalah penelitian diskriptif, pengumpulan data dilakukan dengan wawancara, observasi, dan check list dengan cara meneliti rekam medis pasien penyakit pada sistem pencernaan. Sampel penelitian ini diambil dengan cara *Simple Random Sampling* dari bulan Januari, Februari, dan Maret tahun 2019 sebanyak 80 rekam medis pasien penyakit pada sistem pencernaan. Secara keseluruhan hasil penelitian menunjukkan keakuratan kode diagnosis penyakit pada sistem pencernaan yaitu 21,25 % termasuk dalam kategori akurat dan 78,75 % termasuk dalam kategori tidak akurat. Faktor yang menghambat keakuratan kodifikasi adalah petugas yang belum memahami sepenuhnya tentang kodifikasi penyakit serta belum pernah melakukan pelatihan khusus tentang kodifikasi penyakit. Sarana yang digunakan adalah yaitu tabel bantu yang berisikan kode-kode penyakit yang sering terjadi saja, dan masih tidak lengkap.

ANALYSIS OF ACCURACY CODIFICATION DISEASE DIGESTIVE SYSTEM BASED ON ICD-10 IN PUBLIC HEALTH CENTER OF LANDASAN ULIN BANJARBARU

The accuracy of diagnosis codes is very importance of a disease because it produces the correct information and can be justified. The results of the coding should reflect the patient condition and the action or procedure that the patien is accepted. The purpose of this study was to determine the accuracy of disease codification in the digestive system based on ICD-10 Medical record staff as the code giver is responsible for the accuracy of the code of a diagnosis that has been determined by medical personnel. The purpose of this study was to determine the accuracy of disease codification in the digestive system based on ICD-10. The type of research used is descriptive research, data collection is done by interview, observation, and check list by examining the medical records of patients with diseases of the digestive system. The sample of this study from taken by simple random sampling January, February and March 2019 with 80 medical records of patients with diseases of the digestive system. Overall the results of the study show the accuracy of the diagnosis code of the disease in the digestive system which is 21.25% included in the accurate category and 78.75% included in the inaccurate category. Factors that inhibit the accuracy of codification are officers who have not fully understood the codification of disease and have never done any special training on disease codification. The tools used are the auxiliary table which contains codes of diseases that often occur only, and are still incomplete.
