Tinjauan Pelaksanaan Pendokumentasian Formulir Catatan Perkembangan Pasien Terintegrasi Berdasarkan SBAR Guna Menunjang Pelaksanaan Akreditasi SNARS Edisi 1 Di RSU Syifa Medika Tahun 2019.

Kelengkapan pengisian formulir sangat mutlak dalam penilaian akreditasi dimana mengacu kepada standar pelayanan minimal rekam medis mengenai kelengkapan rekam medis harus 100% lengkap. Terdapat 8 rekam medis pendokumentasian komunikasi efektif dengan menggunakan metode SBAR masih kurang lengkap di RSU Syifa Medika. Tujuan penelitian adalah mengetahui pelaksanaan pendokumentasian formulir CPPT berdasarkan SBAR guna menunjang pelaksanaan akreditasi SNARS edisi 1. Metode penelitian ini menggunakan deskriptif yaitu menjelaskan atau menggambarkan mengenai kelengkapan pengisian *Situation (S)*, *Background (B)*, *Assessment (A)* dan *Recommendation (R)*. Subjek penelitian pada penelitian ini yaitu seluruh rekam medis rawat inap pada bulan Januari sampai dengan April tahun 2019 berjumlah 1.983 rekam medis dan teknik *sample* yang digunakan yaitu *Probability Sampling* yaitu *Simple Random Sampling*. Berdasarkan hasil penelitian, kelengkapan pendokumentasian formulir CPPT berdasarkan komunikasi efektif metode SBAR untuk *Situation (S)* yaitu 76,84%, *Background (B)* yaitu 81,05%, *Assessment (A)* yaitu 95,78% dan *Recommendation (R)* yaitu 97,89%. Sebaiknya dilakukan sosialisasi terhadap profesi tenaga kesehatan yang belum mengetahui tata cara komunikasi efektif dengan metode SBAR agar penilaian akreditasi lebih baik.

Review Implementation of Integrated Patient Development Form Documentation Based on SBAR To Support the Implementation of SNARS Accreditation Edition 1 in RSU Syifa Medika in 2019.

The completeness of filling out the forms is absolutely essential in the accreditation assessment where referring to the minimum medical standard medical records regarding the completeness of the medical record must be 100% complete. There were 8 medical records documenting effective communication using the SBAR method still not complete at RSU Syifa Medika. The purpose of the research was to find out the implementation of the documentation of CPPT forms based on SBAR to support the implementation of SNARS edition 1 accreditation. The method of this research was descriptive which explained or described the completeness of filling Situation (S), Background (B), Assessment (A) and Recommendation (R). The research subjects in this study were all inpatient medical records from January to April 2019 are 1,983 medical records and the sample technique used was Probability Sampling, Simple Random Sampling. Based on the results of the research, the completeness documentation of CPPT forms based on effective communication of the SBAR method for Situation (S) was 76,84%, Background (B) was 81,05%, Assessment (A) was 95,78% and Recommendation (R) was 97,89%. It is best to do a socialization of the profession of health workers who do not yet know the effective communication procedures with the SBAR method so that the accreditation assessment is better.
