### **TINJAUAN PENGELOLAAN REKAM MEDIS DALAM MASA TRANSISI REKAM MEDIS ELEKTRONIK DI RUMAH SAKIT BHAYANGKARA TK.III BANJARMASIN**

Fasilitas pelayanan kesehatan harus menerapkan sistem pencatatan rekam medis pasien secara elektronik. Rumah Sakit Bhayangkara Tk.III Banjarmasin masih menggunakan rekam medis kertas dalam masa transisi ke rekam medis elektronik, terdapat rekam medis kertas rusak karena proses penyimpanan yang kurang baik salah satunya diletakkan di lantai. Tujuan penelitian mengetahui gambaran pengelolaan rekam medis dalam masa transisi rekam medis elektronik. Metode penelitian ini penelitian kualitatif dengan pendekatan naratif. Subjek penelitian ini adalah 2 orang petugas rekam medis, 1 orang staf unit informasi dan teknologi, 1 orang kepala unit informasi dan teknologi, dan 1 orang kepala unit rekam medis. Instrumen penelitian menggunakan pedoman wawancara dan pedoman observasi. Hasil penelitian didapatkan sistem penyimpanan rekam medis manual menggunakan sistem desentralisasi dan menggunakan penyimpanan rak statis untuk rekam medis rawat inap. Sarana dan prasarana yang dimiliki ruang penyimpanan rekam medis sudah terpenuhi sesuai kebutuhan pengelolaan rekam medis yang berkaitan dengan penyimpanan. Rumah sakit telah memiliki Surat Keputusan Direktur dan standar operasional prosedur yang mengatur rekam medis elektronik dan SIMRS. Pelaksanaan rekam medis elektronik untuk pelayanan rawat jalan telah sesuai Peraturan Menteri Kesehatan Republik Indonesia Nomor 24 Tahun 2022 pasal 13 tentang penyelenggaraan Rekam Medis yaitu registrasi, pendistribusian data, pengisian informasi klinis, pengolahan data, penginputan, penyimpanan, penjaminan mutu, transfer isi rekam medis. Sebaiknya evaluasi berkala pengelolaan implementasi rekam medis elektronik, khususnya untuk rawat inap, dan pastikan berjalan sesuai dengan regulasi PMK Nomor 24 Tahun 2022.

### **OVERVIEW OF MEDICAL RECORDS MANAGEMENT IN THE TRANSITION PERIOD OF ELECTRONIC MEDICAL RECORDS AT BHAYANGKARA TK.III BANJARMASIN HOSPITAL**

*Health service facilities must implement an electronic patient medical record recording system. Bhayangkara Tk.III Banjarmasin Hospital is still using paper medical records in the transition period to electronic medical records, there are damaged paper medical records due to poor storage processes, one of which is placed on the floor. The aim of the research is to understand the description of medical record management in the electronic medical record transition period. This research method is qualitative research with a narrative approach. The subjects of this research were 2 medical records officers, 1 information and technology unit staff, 1 head of the information and technology unit, and 1 head of the medical records unit. The research instrument uses interview guidelines and observation guidelines. The research results showed that the manual medical record storage system uses a decentralized system and uses static shelf storage for inpatient medical records. The facilities and infrastructure of the medical record storage room have been met according to the needs of medical record management related to storage. The hospital has a Director's Decree and standard operating procedures governing electronic medical records and SIMRS. The implementation of electronic medical records for outpatient services is in accordance with the Regulation of the Minister of Health of the Republic of Indonesia Number 24 of 2022 article 13 concerning the implementation of Medical Records, namely registration, data distribution, filling in clinical information, data processing, inputting, storage, quality assurance, transfer of medical record contents. Periodically evaluate the management of the implementation of electronic medical records, especially for inpatient care, and ensure that it is running in accordance with PMK regulation Number 24 of 2022.*
