Gambaran Standar Pelayanan Minimal Rekam Medis Berdasarkan Kepmenkes Nomor 129/Menkes/SK/II/2008 di Rumah Sakit Aveciena Medika Tahun 2019.

Standar pelayanan minimal sangat mutlak diterapkan oleh rumah sakit guna menunjang proses akreditasi rumah sakit. Standar pelayanan minimal rekam medis di Rumah Sakit Aveciena Medika untuk pendaftaran pasien rawat inap, pengembalian rekam medis dan kelengkapan rekam medis masih belum sesuai dengan ketentuan. Tujuan penelitian adalah mengetahui standar pelayanan minimal rekam medis rawat inap berdasarkan Kepmenkes No. 129/Menkes/SK/II/2008. Metode penelitian ini menggunakan deskriptif yaitu menjelaskan atau menggambarkan standar pelayanan minimal rekam medis untuk rawat inap. Subjek penelitian pada penelitian ini yaitu seluruh rekam medis rawat inap pada bulan Januari sampai dengan Februari tahun 2019 berjumlah 235 rekam medis dan teknik *sample* yang digunakan yaitu *Probability Sampling* yaitu *Simple Random Sampling*. Berdasarkan hasil penelitian, waktu pendaftaran pasien rawat inap sesuai dengan standar pelayanan minimal rumah sakit yaitu hanya 12 (25,53%) pasien dan belum sesuai yaitu sebesar 35 (74,47%) pasien. Pengembalian rekam medis pasien rawat inap sesuai standar pelayanan minimal rumah sakit sebanyak 22 (46,8%) rekam medis dan belum sesuai yaitu sebanyak 25 (53,2%) rekam medis. Kelengkapan rekam medis pasien rawat inap sesuai dengan standar pelayanan minimal yaitu hanya 15 (31,91%) rekam medis dan belum sesuai yaitu sebanyak 32 (68,09%) rekam medis. Sebaiknya rekam medis rawat inap segera dikembalikan ke instalasi rekam medis oleh perawat ruang perawatan setelah diisi lengkap oleh dokter dan rak penyimpanan rekam medis dilakukan penambahan agar rekam medis tersusun rapi.

Overview of Minimum Medical Record Standards by Minister of Health Number 129/Menkes/SK/II/2008 in Aveciena Medika Hospital in 2019.

Minimum standards are absolutely essential to be applied by hospitals to support the hospital accreditation process. Minimum standards for medical records at Aveciena Medika Hospital for inpatient registration, return of medical records and completeness of medical records are still not in accordance with the standard. The purpose of the research was to find out the minimum standard of inpatient medical records based on Kepmenkes No. 129 / Menkes / SK / II / 2008. This research method uses descriptive, explaining or describing the standard minimum medical record for inpatient care. The research subjects in this study were all inpatient medical records from January to February 2019 are 235 medical records and the sample technique used was Probability Sampling, Simple Random Sampling. Based on the results of the research, the time of registration of inpatients was in accordance with the hospital's minimum standard, which was only 12 (25.53%) patients and not yet in standard was 35 (74.47%) patients. The return of medical records of inpatients according to the hospital's minimum standards was 22 (46.8%) medical records and not yet in standard was 25 (53.2%) medical records. The completeness of the medical records of inpatients in accordance with the minimum standard is only 15 (31.91%) medical records and not yet in standard was 32 (68.09%) medical records. It is recommended that the inpatient medical record be returned to the medical record department by the nurse after being filled in completely by the doctor and the medical record storage rack is added so that the medical record is neatly arranged.
